



Vendor Member – Client Practitioner Membership Agreement

As a part of the \$2,000 Vendor Membership benefits package, a TPRA vendor member organization in good standing has the option to provide each of their clients with a free, annual TPRA Practitioner Membership. This benefit is provided to our vendor members in an effort to further the profession of third party risk through knowledge sharing and networking. It is a mutual benefit for the TPRA and vendor membership in that it enhances the third party risk community within TPRA and allows the vendor membership a greater reach when communicating their products/services.

Details of this Benefit:

- Each vendor organization wishing to participate in the free client practitioner membership must be in good standing (annual dues for the current plan year are paid in full and there are no outstanding fees for the vendor member organization).
- Each vendor organization will receive a special link they may provide to each of their clients to sign up for the free practitioner membership plan. This link may only be used by the organization it was provided to and may not be shared as it is specific to that organization. This is to ensure clients of a specific vendor member organization can be appropriately tracked.
- Vendor member organizations may only provide the link to current clients of theirs. A client is defined as an individual currently using the products/services of the vendor member.
- Clients must be specific to third party risk. This can include individual in the legal, procurement, vendor management, audit, third party security, and information security fields. This **does not** include individuals in the sales, marketing, or development fields.
- Free client practitioner memberships will be capped at 500 for each vendor member organization. Vendor members wishing to purchase additional client practitioner memberships above the 500 cap may do so by reaching out to Julie Gaiaschi at Julie@tprassociation.org.
- Each free client practitioner membership will be good for one year from the time the client signs up for the membership, even if the vendor member does not renew their vendor membership within said year.
- Client practitioner memberships will not renew for free the following year. The client practitioner member will either need to renew at the current TPRA registration rate or purchase another free client practitioner membership through the new link provided to the vendor member upon their renewal.
- The client practitioner membership link for the vendor member organization will automatically be disabled upon the expiration of the vendor's membership or if the vendor member is no longer in good standing with the TPRA.
- If a client is already a member of the TPRA, a refund will not be provided to said client and they will need to finish out their purchased plan year.
- If a client terminates relations with the vendor member, the client will be able to finish out their Client Practitioner Membership plan for the year.

By participating in this program, the vendor member agrees to adhere to the details of this benefit and shall only provide their specific client practitioner membership link to their current clients who are

within a third party risk-related field. This vendor member benefit is not transferrable and the terms of this benefit may change at the discretion of the TPRA.

On a quarterly basis, TPRA will supply a list of those clients who have signed up with the TPRA using the vendor member link. Vendor member will then confirm the clients who signed up are in fact current clients and in a third party risk-related field.
